Buyer's responsibilities

1. The buyer agrees to have the puppy/dog examined by a veterinarian during the first 48 hours (during regular vet's business days) after the purchase agreement was signed.
2. The buyer must call the seller shortly after the puppy/dog's examination to report the results of the vet's findings.
3. The buyer agrees to feed breed specific dog food.
4. The buyer agrees to have a certified veterinarian do yearly examinations and vaccinations, which the puppy/dog must have according to state laws.
5. The buyer is solely responsible not to mismanage the health of said puppy/dog. Age appropriate housing and exercise has to be provided by buyer.

Regulations

This agreement shall be governed by the laws of the state of North Carolina to the exclusion of other form and constitutes the entire agreement between the parties.
